### **CALL FOR NOMINATIONS**

Election time is coming and we need good people from around the state to continue the tradition of dedication and commitment set by current and past officers and board members. Become involved; submit a nomination now. The Nomination Committee of the TJA will be selecting a slate of candidates for the following positions:

#### THIRD VICE PRESIDENT

The person elected will serve progressively through the presidential preparation chairs to become your president in the year 2015. Give some serious thought to this nomination and present yourself, or someone else, to the Nomination Committee. The eligibility for this elected office is contingent upon active "**professional**" membership in good standing with the Association for a period of one year prior to election. The member must have served at least one year on the Board of Directors in order to be eligible for this position. The member elected will be required to attend approximately four meetings per year.

#### **BOARD OF DIRECTORS - Two Positions Available**

The Board of Directors shall be the governing body of the Association. The President shall be the presiding officer at all board meetings. The Board shall be empowered to authorize expenditures for the general business of the Association, authorize additional expenditures, and set appropriate charges. The Board may enter into any agreement or contract with other personnel or organizations for the advancement of the Association. Eligibility for this elected office is contingent upon active "professional" membership in good standing with the Association for a period of one year prior to election. Members elected to this position shall serve a three year term in office.

#### **NOMINATION PROCESS**

Nominations with an attached resume, picture, and letter of endorsement from the agency head are to be returned to TJA Headquarters, Attention: Sharese Hurst, Box 2296, Huntsville, Texas 77341-2296. All packets will be sent to the Nomination Committee Chair for verification of eligibility and distribution to committee members.

#### **Guidelines for nominations**

- Individuals must be professional members in good standing as specified in the by-laws at the time of nomination.
- Nominating Committee members shall not be considered for office.
- 3. Only hard copies of nominations will be considered. Self-nominations are acceptable.
- Office being sought shall be identified in the nomination.

- Endorsement of the affected agency head must accompany the nomination. Nominations lacking the agency head's endorsement will not be considered for office.
- 6. Elections shall be conducted in accordance with the provisions of Article VI of the by-laws.

Nominations must be received by March 15, 2012. All nominations shall contain the following for consideration: Full Name, Current Occupation, Official Title, Business Address and Phone Number, a brief biographical sketch (not to exceed 50 words), letter of endorsement from the agency head, and a picture to be included on the ballot. Nominations received after the deadline cannot be considered.

#### CRITERIA FOR NOMINATION

- A. <u>Jailer of the Year Professional Service</u> This award is given to an individual working in county corrections who has demonstrated a commitment to professional service at his/her agency by making outstanding contributions to county corrections that exceed basic ability and expected performance.
- B. <u>Jailer of the Year Valor</u> This award is given to an individual working in county corrections who demonstrated courage or valor in the face of danger while in the performance of his/her official duties.
- C. Jerry Baggs Leadership Award This award is presented to an individual employed in the field of county corrections who has demonstrated outstanding leadership in and appreciation of the field of county corrections. He or she has exhibited a sincere commitment to the professional advancement of county corrections personnel.





# Given the Chance to Give

On November 17, 2011, the Jones County Jail hosted a donation bin for the Mission: Thanksgiving 2011 food, clothing, and fundraising drive for the Love and Care Ministries of Abilene. This non-profit organization travels the streets of Abilene daily, dispersing much needed food and clothing to the homeless, as well as, establishing soup kitchens, dental clinics, and mobile medical units.

Collecting for the needy is not uncommon for those of us in law enforcement and corrections, as some departments hold community drives on a fairly regular basis. Charitable attributes seem a natural extension of the career paths we have chosen. Yet, what is often overlooked while seeking donations, is the sizable percentage of our community residing in our facility with resources available. We regularly disallow, disregard as moot, or tend to "forget" to offer inmates the chance to give to whatever cause for which we are rallying.

As many know, participating in charitable functions brings unparalleled rewards to the contributor. Endless benefits can be gained by the selfless act of helping those less fortunate. With this in mind, Mission: Thanksgiving 2011 was opened to the Inmate Population of the Jones County Jail. With a signed, voluntary release from the County Attorney, inmates were offered the opportunity to make monetary donations from their commissary accounts. The response was unexpectedly overwhelming, and the numbers speak for themselves. Eighty-two percent of the inmates with funds available made donations. Seventyseven percent of those had less than ten dollars in their accounts. Eleven percent who made monetary donations depleted their accounts to the cause. Indigent inmates contributed socks, t-shirts, and thermal underwear they had purchased beforehand. Many inmates who were able, gave both monetary and clothing contributions. Current charges or criminal history showed no apparent influence on whether or not an inmate chose to contribute, with the percentages similar to those of the overall misdemeanor/ felony ratio of the population as a whole. Of contributors, 23% were inmates with a pre-sentence or post-sentence misdemeanor(s) as their highest level of offense. Seventyseven percent were inmates with a pre-sentence or postsentence felony(s) as their highest level of offense. Forty-six percent of total contributors were currently charged with or had a prior assaultive felony conviction on their record.

Allowing the inmates the opportunity and an outlet to channel participation in charity seemed to have a positive affect on jail climate, drawing focus away from their own circumstances to others in even worse situations. Attitudes were somber and comments were sobering as donations were made. One young man said, "Just because I'm locked up doesn't mean I don't care about other people." An older man said, "I've been there, (homeless) and it's a horrible place to be." A female inmate stated, "Even though it's not ideal, I do have a roof over my head and food 'brung' to me." Speaking of an incident that occurred a few weeks earlier, one man reflected, "I have a lot to be grateful for, I could have been dead last month."

Sergeant Joy Parker, tasked with going cell to cell discussing the charity, was apprehensive on how it would be received, "I didn't know if anybody would be interested, or what kind of reaction there would be." After Sergeant Parker explained what the funds would be used for, inmates became very introspective and began openly discussing everything they had to be grateful for; family, friends, a warm place to sleep, and jail food. With most of the inmate population consisting of inmates of a low socio-economic status, many were unable to make large donations. However, "When they found out that the charity could prepare a sack lunch for thirty-six cents, they began calculating out loud how many homeless people they could feed with their donation and they were very proud," said Sergeant Parker.

John D. Rockefeller Jr. said, "Don't think of charity as a duty, but as a privilege." When viewing charity from the perspective of benefits to the contributor, it's easy to recognize how incorporating it into the confines of a facility would serve. This is especially true for those with limited resources and funding for rehabilitative programs and activities. From partaking in close-knit community fundraisers to furnishing packages for global-wide disaster relief, providing opportunities for acts of philanthropy would be invaluable for all involved.

#### FROM HIS CHAPLAIN

#### "WHY AM I?"

They can assist with putting on trainings along with answering any questions about the current jail standards. The Commission is always willing to help. I recently contacted Assistant Director Shannon Herklotz about our department hosting a classification class to refresh our officers on the subject. He was more than willing to send Jail Inspector Robert Green to our department to instruct the class. The Jail Commission and inspectors are not "the bad guys," in fact, they are one of the greatest assets to the jail system.

#### IS AN F.T.O. PROGRAM BENEFICIAL TO A DEPARTMENT?

One of the many obstacles we face in the field of corrections is training officers to be efficient and effective. Take a walk with me and think back to when some of us were hired. We were thrown a set of keys and told to hit the floor. We were also told that if they had a "sheet" hanging on their door they are "on watch" and we were to be sure to sign the "sheet" every 15 minutes.

Despite the lack of training, we turned out to be good officers. However, with today's new technology, State and Federal mandates, and the Jail Commission standards, it takes more than a ten minute spill. To which every department should have a good training program in an effort to insure that new officers are getting properly trained.

I was recently given the task of overseeing the training of our new officers. I began by taking a look at what we, as a jail, were currently doing. I found out that our department was doing basically the same thing that was done for many of us years ago. We were showing a few videos, giving a tour of the jail, and walking the new recruit around with another officer for about a week. We then put the employee on a shift and hoped they were able to stay afloat. We also prayed that the new recruit had been paired with an officer that did things correctly.

Looking at this, I found that there were many officers that did not know the proper ways of doing things, possibly due to lack of training. There are many liabilities that we face as officers, whether it be criminal or civil. I have seen and heard of good officers who were let go due to an action made on their behalf. I believe that sometimes this may have occurred because they were not properly trained.

When putting together your F.T.O Program, you need to select officers that you know are very knowledgeable about their job and the policies of your department. Secondly, choose officers that care about their job and are willing to help others. If you choose an officer that does not care then you are going to have new officers that are not trained properly. This could soon lead to a department full of mediocre officers.
