

JAILPARDY! ...Jail "party!" 2015

...New Kids on the Block

The Texas Commission on Jail Standards (TCJS) held its second annual "Jailparty" Tournament at the 29th Annual Texas Jail Association Conference held at the Renaissance Hotel in Austin, Texas, May 13-14, 2015. And boy howdy, it did not disappoint.

Before we get into the results, we had 27 individuals from 14 different counties participated in this year's "Jailparty" game. There were four individuals from the Travis County Sheriff's Office; three individuals from the Lubbock County Sheriff's Office, the Wilson County Sheriff's Office and the Titus County Sheriff's Office; two individuals each from Hale, McLennan, Dallas and Denton Counties and one individual each from Robertson, Tarrant, Guadalupe, Navarro, Freestone and Brown Counties.

The results from the "Jailparty" tournament was all about one thing, new blood. In year's past, the good folks over at the Travis County Jail dominated this tournament from start to finish. As we all know, all good things must come to an end. While the group from Travis County has no reason to hang their heads, 2015 ushered in a new champion.

As in year's past, we added some new and more challenging questions to this new format. Once again, the individuals did not appear to be intimidated and pushed through the questions with relative ease. The competitiveness of these individuals and their knowledge of minimum jail standards is amazing! This year was no exception. Match after match and round after round, the pressure mounted. In the end, Lubbock County Officer **Wade Goolsby**, better known as Bocephus (as tabbed by his Sheriff, **Kelly Rowe**), was crowned the champion of this year's "Jailparty" game. Mr. Goolsby came from behind in his very first match and won on the final "Jailparty" question. That, to me, is the one thing about this game that differs from the old courtroom challenge. In the past, you had to answer every question correctly or face

possible elimination. In the new format, there is more strategy involved in that you have to pick your categories more strategically and in the end, you have to wager appropriately to advance. "Bocephus" wagered correctly which allowed him to advance. Mr. Goolsby displayed an unbelievable knowledge of minimum jail standards, and you could see his confidence grow after he survived that opening match. Tremendous job!

The 2nd Place individual from this year's challenge is Assistant Jail Administrator **Les Karnes** from Brown County. The ironic story behind Mr. Karnes' participation is that he was fully prepared to be a spectator at this year's event. When the TCJS staff members were trying to round out our 27 person field, we approached Mr. Karnes about participating and he reluctantly agreed. A few matches later, Mr. Karnes found himself in the championship match with a chance to win the whole kit and caboodle. I know Mr. Karnes did not expect to be in the final round when the day started but to almost win the whole tournament says a lot about Mr. Karnes' knowledge of minimum jail standards. Mr. Karnes fought hard to the very end and gave the other two contestants a run for their money. And for that, I commend

you on a job well done. Excellent Job!

Rounding out the top three is none other than Captain **Greg Martin** from Guadalupe County. Like Mr. Goolsby and Mr. Karnes, Mr.

Martin did not lose a match until the final round. Martin was also a late entry into the tournament as he too was willing to be a spectator to this year's tournament. However, he relented and low and behold, there he was, in the finale.



Martin navigated through the bracket with a couple of hard fought matches to get into the final match. In the end, Martin came up a little short in the point column; he has nothing to be ashamed of. Martin represented himself and Guadalupe County Sheriff's Office very well. Great job!

Once again, due to the generosity of the Texas Jail Association, we were able to present the 1st Place, 2nd Place, and 3rd Place individuals with trophies for their efforts. I would like to thank TJA President **Kim Howell** and board members for providing the funds to purchase those trophies. The trophies were extremely nice, and I think each winner will be proud of their award for years to come. I would also like to congratulate all of the individuals that participated. Without your participation, this game would not have been the success that it was. All of us at TCJS appreciate all of you that participated in this year's event.

As with any new format or change, there are learning experiences and difficulties that you encounter. Introducing the new "Jailpardy" format and carrying out the game with no major glitches is an accomplishment in itself. However, if any of you have any suggestions or comments that may improve the game as a whole, feel free to share your ideas with our staff. Your suggestions and comments are

welcomed! I would also like to thank Planner **Jason Ross** and especially Inspector **Jackie Semmler** for their hard work and dedication in preparing the game and inputting all of the questions into a playable format. I cannot thank you guys enough. I really appreciate your efforts.

The staff of the Texas Commission on Jail Standards would like to take this opportunity to thank the sheriff's and administrators for allowing your jail staff to not only participate in the Jailpardy game, but for allowing them to attend the conference as a whole. We would also like to thank those who participated in the tournament as well as those spectators that attended the sessions. I would like to encourage more counties and individuals to participate in next year's competition. We continue to see numerous people attend the game but fail to enter. I would like to extend a challenge to all of you that read this article, get your staff ready now! Begin learning the standards and enter the game next year. By increasing your knowledge of minimum jail standards, you will limit your liability in the jail. That alone, will make for a more safe and secure environment to work in. completion of the Dallas County Jail Medical Modification Project by hosting a ribbon cutting ceremony and tour of the new facility March 16, 2015.



The Dallas County Jail Medical Modification Project, also known as the Med Mod, is located within the North Tower Jail. It is a one-of-kind facility that renovated and modified 138,657 sq. feet of existing space in the lowest

three floors of the Lew Sterrett North Tower Jail to create a stand-alone centralized medical-mental health services facility, including separate medical and mental health clinics, a full service pharmacy, a dental office, a radiology unit, and two intensive care units along with medical staff offices. The Med Mod facility will improve the delivery of medical and mental health services to Dallas County Jail inmates and offer services not usually found in the jail system.



Each year, the Dallas County Jail books in an average of 100,000 inmates annually with about 55% of the inmates suffering from an acute or chronic illness that requires some degree of medical care. The Med Mod facility will assist and keep down the number of inmate visits to Parkland's Emergency Room. The medical care floor will house 137 inmates. The mental health care floor will house 145 inmates. Construction on the project started in November 2012 and was completed in February 2015.

"The Medical Modification Project facility promises to change the nature of medical treatment at the jail and it could not have been accomplished without the teamwork and consolidated efforts demonstrated by the






