- Must be less than 25 years of age at time of application.
- Must have a cumulative grade point average of at least 2.5.
- Must have completed at least one semester of college.
- Must be enrolled as a full time student during semester the application is submitted. The general rule will be for 12 semester hours undergraduate, 9 semester hours for graduate students.
- Must not have been convicted of a crime, which would make an individual ineligible for employment in his/ her field study.
- Must submit with application a brief biographical sketch and narrative, written in the applicant's own words, stating why the applicant believes he/she is deserving of a scholarship award. May include personal accomplishments, activities and experiences, and may not exceed two (2) typewritten, double-spaced pages in length.
- Must be a son, daughter, stepson, stepdaughter or grandchild of an Active Texas Jail Association member serving the State of Texas, pursuing a degree.


\*\*Active Texas Jail Association Member: Member in good standing for at least one full year and current on membership dues for year applying.

### The Foundation of Transformation

In the Summer 2015 issue of *Key Issues*, TJA President **Shane Poole** talked about the key question that arose every time he found himself in a new situation: "Why am I here?"

It's a great question that's attached to so many other critical questions. The only problem is, many of us never ask ourselves the critical questions and, when we do, we rarely answer them in a way that's useful or productive.

Let's add three more questions that can transform your life. Now, you may be tempted to think that these questions have little to do with corrections. As you'll see, they lie at the core of your job performance.

The three questions are:

- Who am I?
- What do I want?
- How am I going to get it?

On the face of it, these questions may seem like clichés that don't really work. That's because so many people never unlock the power contained within these questions.

Most people who answer the questions typically give responses like, "I wish my supervisor wasn't a jerk." "I want to lose weight." "I want to be wealthy." "I want to be happy."

Unfortunately, these kinds of answers don't really mean much. They're wishes, dreams, hopes that your brain can't comprehend.

The key to answering these questions is to be as specific as possible. Armed with detailed answers to those questions, you'll be able to face some of the most challenging situations of your life and get outcomes you never thought possible.

#### **The Questions**

#### Who am I?

A question like "Who am I?" will push you into questions like: What are my beliefs and values? What is the role of religion or spirituality in my life? Am I living my beliefs? What is the story I invented about myself when I was five, six, or eight years old in order to feel worthy, accepted, and loved? If I didn't

feel worthy, accepted, and loved as a child, how is the absence of those feelings now expressing itself in the adult version of me? Am I controlling, manipulative, and gossipy? Do I sabotage relationships? Do I get defensive when anyone criticizes me?

#### What do I want?

This question will push you to define the details of your life, to translate the vision in your mind into specifics, frequently driven by numbers. What do I want my blood pressure to be? How many pounds do I want to weigh? How many dollars do I want to have in the bank? Do I want to live in an apartment or a house? What kind of car do I want to drive? You get the idea.

Your brain is loving this now. It can make sense of the answers you give to these questions because they're specific, concrete, and real; they're no longer abstract and nebulous. Keep going and ask yourself as many specific questions about as many different aspects of your life as possible.

#### How am I going to get it?

This question becomes much easier to answer now that you've contemplated the answers to the questions "Who am I?" and "What do I want?" You may not even realize it but, by answering the first two questions, you have now defined your beliefs, values, and priorities. It is only with those in place that you can create meaningful goals.

When you have meaningful goals based on priorities, it becomes much easier to say "no" to people. So many people are burdened by feelings of guilt and obligation that they say "yes" to every request that comes their way. And then they wonder why they don't get the most important things in their work lives and home lives done.

Knowing who you are and what you want means you can now design a plan for how to get the things you want.

#### The Equation

When you start answering the three critical questions discussed above, you can start integrating a simple

equation into everything you do that will change your life, if you let it.

The equation is: E + R = O.

E is an event—any event—that occurs. R is your response to that event. O is the outcomes you get in life, whether at work or at home.

So often people fool themselves that events determine their responses. But events are value free—they just "are." You choose how you will respond to every event that happens in your life.

Instead of focusing on the event, it's more powerful to focus on your responses. That is the way to get the outcomes you want in life.

#### **Application to Corrections**

The powerful combination of these three questions and the equation will guide you in your decisions and your actions. They will inform how you interact with a difficult supervisor and how you treat inmates. They will act as a road map to help you decide what's worth arguing over and what's not.

Rolling your eyes at a supervisor, gossiping about people around you, mistreating people you work with all tell you that your responses are insufficient.

The three questions and the equation have a simple built-in evaluation mechanism. If you aren't getting the outcomes you want in your work life, something isn't working. You have to change your responses. That is always the first place to look.

When things aren't working well, revisit your answers to the three questions and then review the responses you're giving to the events around you. Your ability to do this effectively will change your performance at work and, in all likelihood, your life.



## Jail Administration Management and Operations (JAMO) Class Seventeen

From class number one in September 2006 to class number seventeen in September 2015, attendees go home on the last day with a whole new awareness. For some, it is life changing and others it is career transforming. The week is completely devoted to jail management and the responsibilities of administrating a jail. Attendees come from all over the state with jail size varying from five beds to five thousand beds. After a week together, the participants realize that no matter what the jail volume, the issues, problems and accountabilities remain the same.

The session began on Sunday, September 20, 2015 with opening remarks from the individuals involved with the development and formation of the initial program. Limestone County Sheriff **Dennis Wilson**, Gregg County Sheriff **Maxey Cerliano**, Former Trinity County Sheriff and current Jail Administrator in Polk County **Brent Phillips**, presented the history and welcome to the applicants. Sheriff Wilson provided an overview of the legislative session and the future of mental health issues in the jails. Bosque County Jail Administrator **Mary Farley** began the session with a presentation on wellness, fit for duty and stress, introducing the daily voluntary walks around the Sam Houston State University Campus during the week of training.

The administrators observed presentations on Supervisory Skills, Managing Generations, Behavior Styles, Staff Training, Fiscal Issues, Con Games, Legal Issues, Human Resource Concerns, The Responsibilities of a Jail Administrator, Professionalism and Ethical Decisions, The Leadership Toolbox and Legacy Leadership.

On the final night, it has become a recent tradition to recognize several outstanding attendees. Those recognized in the 17th JAMO Class for Leadership were **Tim Cannon** from Harris County and **Mike Davenport** from Hays County. Those chosen by the class for Inspiration were Louis Valdez of Bexar County and Tim Cannon of Harris County.

Jerry Dale Stevens and Rick Armstrong were awarded "Super Walkers" awards by Mary Farley for walking every day, sometimes twice a day during the week of training. All others participating in the walks were given golden batons.

#### **CALL FOR NOMINATIONS**

Election time is coming and we need good people from around the state to continue the tradition of dedication and commitment set by current and past officers and board members. Become involved; submit a nomination now. The Nomination Committee of the TJA will be selecting a slate of candidates for the following positions:

#### THIRD VICE PRESIDENT

The person elected will serve progressively through the vice presidential chairs to become your president. Give some serious thought to this nomination and present yourself, or someone else, to the Nomination Committee. The eligibility for this elected office is contingent upon active "**professional**" membership in good standing with the Association for a period of one year prior to election. The member must have served at least one year on the Board of Directors in order to be eligible for this position. The member elected will be required to attend approximately four meetings per year.

#### **BOARD OF DIRECTORS - Two Positions Available**

The Board of Directors shall be the governing body of the Association. The President shall be the presiding officer at all board meetings. The Board shall be empowered to authorize expenditures for the general business of the Association, authorize additional expenditures, and set appropriate charges. The Board may enter into any agreement or contract with other personnel or organizations for the advancement of the Association. Eligibility for this elected office is contingent upon active "professional" membership in good standing with the Association for a period of one year prior to election. Members elected to this position shall serve a three year term in office.

#### **NOMINATION PROCESS**

Nominations with an attached resume, picture, and letter of endorsement from the agency head are to be returned to TJA Headquarters, Attention: Sharese Hurst, Box 2296, Huntsville, Texas 77341-2296. All packets will be sent to the Nomination Committee Chair for verification of eligibility and distribution to committee members.

#### **Guidelines for nominations**

- Individuals must be **professional** members in good standing as specified in the by-laws at the time of nomination.
- 2. Nominating Committee members shall not be considered for office.
- 3. Only hard copies of nominations will be considered. Self-nominations are acceptable.

- 4. Office being sought shall be identified in the nomination.
- 5. Endorsement of the affected agency head must accompany the nomination. Nominations lacking the agency head's endorsement will not be considered for office.
- 6. Elections shall be conducted in accordance with the provisions of Article VI of the by-laws.

Nominations must be received by March 10, 2016. All nominations shall contain the following for consideration: Full Name, Current Occupation, Official Title, Business Address and Phone Number, a brief biographical sketch (not to exceed 50 words), letter of endorsement from the agency head, and a picture to be included on the ballot. Nominations received after the deadline cannot be considered.

The By-Laws Committee submitted proposed changes to the Texas Jail Association Board of Directors. We feel these changes will benefit our membership. The Board of Directors voted to submit the changes to the general membership to be voted on at our Annual Conference in May of 2016.

The proposed changes affect:

#### Article II-Members

#### Voting

This amendment will allow each eligible member of the Association to vote for the Board of Directors or any by-law changes regardless of attendance at the annual conference. Voting will be conducted either in person, by mail, or electronically.

#### Article VI-Election of Officers and Directors

#### Eligibility

This amendment limits the number of voting Board members, from the same county, that may serve on the Board of Directors simultaneously to two members.

#### **Biography**

This amendment will give candidates running for the Board the opportunity to submit a biography in several different formats. This flexibility will provide benefits as technology advances.

#### **Article X-Amendments**

This amendment will allow submissions of proposed changes to the Texas Jail Association By-Laws to work efficiently should Article II amendments (above) pass. Changes will still require a two-thirds majority vote to approve changes of the By-Laws

A copy of the proposed changes have been included in this issue of "Key Issues." The By-Laws Committee will continue to work for you, the membership, to address any and all concerns regarding our Association. ## **By-law Changes**

The Texas Jail Association Board of Directors has approved the following amendments for submission to the General Membership for approval pursuant to Article X, section 1.

This is a single vote proposal as each section is requires adoption to be consistent with the goal of allowing each eligible member a manner in which to cast votes regardless of attendance at the annual training conference and business meeting and meet the changing requirements and abilities of electronic posting and voting.

#### **ARTICLE II – MEMBERS**

Section 2, Voting, to be amended by striking requirement that members be present and further clarifying that the Board may adopt a manner to vote that includes in person, mail, or electronic means.

#### Section 2: Voting

Each voting member is entitled to one vote on each matter submitted for consideration by the Board of Directors (Board). Voting is limited to members present at the time the vote is taken. Voting shall take place at a time and in a manner as set forth by the Board; to include in person, mail, or electronic means.

#### ARTICLE VI – ELECTION OF OFFICERS AND DIRECTORS

Section 1, Eligibility, to be amended by Adding paragraph E as follows:

- E. No more than two elected members from the same county may serve
- on the Board of Directors simultaneously.

Section 3, Elections, amends paragraph B to provide for changes allowing flexibility with voting system to be used, electronic formatting, picture types, and related non-substantial changes that may occur.

B Each candidate may shall submit a biography in a manner as set forth by the Nominations committee for publication to the members. of fifty (50) words or less to be included with the meeting materials.

#### **ARTICLE X – AMENDMENTS**

Section 1, Amendment to By-Laws, to be amended as follows:

Section 1, Amendment to By-Laws

- A. Any motion to change the by-laws of this Association shall be made in writing to the First Vice-President, who serves as Chairman of the By- Laws Committee. The First Vice-President shall submit the recommendations of the By-Laws Committee to the Board which, upon a majority vote, shall distribute the proposal for a vote of the members. prior to the annual training conference. The President shall submit recommended changes to the general membership for ratification at the annual training conference.
- B. Amendments to the by-laws shall be posted during the annual conference for ratification by the membership at the annual business meeting.
- C. (B) Amendments to the by-laws require a two-thirds majority of all votes cast.



## West Texas Tangos Overview

Tango is defined as "Hometown clique." In 1990, the Tango Blast prison gang formed in the Clemens state prison in Brazoria, Texas. When talking about Tango Blast you will often hear a reference to the Four Horsemen. The original four tango cliques were Houston, Dallas, Fort Worth and Austin. Since then cliques have splintered and all major regions have their faction of the Tangos.

The West Texas Tangos are the biggest threat to the community and county jails in Lubbock, Amarillo, Abilene and surrounding West Texas counties. Like other parts of the state the tangos continue to grow and commit crimes at alarming rates. While the number of documented members in the TxGang database is 721, this statistic is on the low side due to lack of reporting and identification of members. The reason reporting number are low is agencies lack the personnel needed to monitor and confirm gang members. Gang members will attempt to hide their affiliations to prevent detection by law enforcement. That is why tattoo recognition is important.

#### **Cartel Ties**

West Texas Tangos have been in business with the Sinaloa Cartel in Lubbock. They make connections every day in federal prisons and county jails. The Cartels benefit tremendously by making connections with local gang members. This allows the Cartels to learn our cities and communities. The Cartels favor setting up outside larger cities in smaller surrounding towns because of the lack of narcotics and gang units.

#### **Tattoos and Identification**

The West Texas Tangos like any other tango use city landmarks, area codes, sports teams and numbers coordinating with the alphabet to signify "WT" I.E "2320" W is the 23rd letter of the alphabet and T is the 20th letter. In Spanish the word "huesos" means bones. Members refer to each other and "Wesso's." Due to similar pronunciation bones are commonly used in tattoos to identify members. West Texas Tangos also use the Texas Tech Double T symbol and we are beginning to see members using the "Jump man" symbol, otherwise

known as the Michael Jordan brand symbol. Michael Jordan's jersey number was 23. This again signifies the W in the alphabet for the West Texas Tangos. Area codes usedby this group are 806, 325 and 432.



**Summary** 

I hope this will inspire other gang units throughout the state to submit an overview of their largest gangs. As we know gangs are constantly evolving and so must we. I would like to have knowledge should any of your homegrown gangsters take a trip to Lubbock County! Thank you all for what you do! Stay safe and please feel free to contact me.

### Bexar County Jail's K-9 Places 5th out of 50 Teams in New Competition

The Bexar County Sheriff's Office (BCSO) has an award-winning employee who is making a name for herself. **Moka**, the K-9 partner of BCSO Deputy **Esequiel Romero**, has just made news at a new competition in Texas. Moka and Romero were the only detention team to participate



in the First Annual South Texas K-9 Competition in Pharr, Texas – and they placed 5th out of 50 teams.

"Here at the Bexar County Adult Detention Center, we strive to provide public safety for the community, staff, visitors and inmates," said BCSO Jail Administrator **Raul S. Banasco**. "Training and competition exercises are key elements in ensuring both Deputy Romero and K-9 Moka are ready to perform their daily duties."



The event, which was sponsored by the Hidalgo County Sheriff's Office on November 10, consisted of 50 dog teams from Hidalgo County, Williamson

County, Border Patrol, Customs Enforcement and Laredo Police, among others. Deputy Romero and K-9 Moka entered two events that involved locating hidden narcotics and included both article searches and vehicle searches. Each narcotic detection event required teams to locate as many hidden narcotic finds as possible in three minutes without any false alerts. The Bexar County team located six hidden narcotic finds without any false alerts.
